

### Question of the Month - What are Protoliths and Provenances?



Protoliths are the parent rocks of metamorphic rocks. The term protolith applies only to metamorphic rocks. The parent components of sedimentary rocks (the sediment from which they are formed) are properly referred to as the provenance. Igneous rocks also do not have a protolith or a provenance – they are formed from magma.

Over the last few months, we have looked at shale and how it can be changed to slate, phyllite, and schist. Shale was a sedimentary rock, the provenance of shale being mud and silt. Bury the shale under the tons of shale and dirt piled on top of it and it was metamorphosed into slate. Add some more pressure and some heat, it became phyllite. With still more pressure and heat, it became schist. In all these cases, the pressure came from a preferred or common direction (up/down as in buried material or side/side as in material along a sliding fault) which allowed foliation – the crystalline structure of the material to be aligned so that the rock could be split into thin sheets.



We also looked at sediments of calcium carbonate formed limestone and then with pressure the limestone was metamorphosed into marble. The sediments are mainly formed from the shells of marine organisms. The shells end up on the sea bottom and are eroded into fine particles. Add some pressure (more shells and sediment on top of them plus the weight of all the water) and they are compacted into limestone. Later, add some more pressure and heat and the limestone is metamorphosed into marble.



Another common provenance – protolith series, although not covered in previous articles in sand as the provenance, sandstone as a sedimentary rock, and quartzite at the metamorphosed sandstone.

# Feature Article Paleontological HR y554 Bill

Greetings Club Members,

This is a follow-up via Virgil G. Richards, Tulsa Rock & Mineral Society on HR554, The Paleontological Resources Preservation Act. It is top priority, PLEASE take time to read it through. –

An exert of the Omnibus Bill package.....

- S. 320 Paleontological Resources Preservation Act (Sen. Akaka, D-HI) (H.R. 554; McGovern, D-MA) Cost: Less than \$500,000 each year and would offset each other over time according to the CBO score. This bill directs the Secretary of the Interior or the Secretary of Agriculture to: (1) manage and protect paleontological resources on federal land; and (2) develop plans for inventorying, monitoring, and deriving the scientific and educational use of such resources. It prohibits the removal of paleontological resources from federal land without a permit issued under this Act, establishes penalties for violation of this act and establishes a program to increase public awareness about such resources.
- S. 320 prohibits: (1) evacuating, removing, or altering a paleontological resource located on federal lands, except in accordance with this Act; (2) exchanging or receiving a paleontological resource, or selling or purchasing a paleontological resource, if the person knew or should have known such resource was illegally removed from federal lands; or (3) making or submitting false records, accounts, or identification of any paleontological resource excavated or removed from federal lands.
- S. 320 requires that information on the nature and specific location of a paleontological resource that requires a permit under this Act or other federal law be withheld from the public, including under the Freedom of Information Act, except under specified conditions.
- S. 320 imposes criminal penalties for violating this Act, which includes serving up to 10 years in prison if convicted.

#### Your Editor

This is getting serious! Please read the attached file, and call your representatives! Remember HR 554, The Paleontological Resources Preservation Act? Well it is now a part of this Omnibus Bill package along with 150 other bills that is soon to be voted on! Just like a pork barrel bill, it's wrapped up with a huge ribbon and being delivered to congress. If this Omnibus Bill passes, we will lose millions of acres of public land that will become designated wilderness areas, and special use areas. The bill will ban any individual from collecting, or even OWNING a vertebrate fossil. The bill may eventually allow the govt. to seize your property along with your rights! Please call your representatives! A lame duck session of congress has been called for the 17th of Nov to vote on this and other bills! Don't let George Bush's legacy include striping us of our rights to use public lands and public resources!
